\$45. Anonymous Services	If you do not want to be identified on the public record as an officer or director of a Florida Corporation you do not have to be listed. Instead we can file you anonymous for a one time fee of \$45.
\$50. 1244 Stock	A Corporate Shareholder is normally allowed to write off only a capital loss of \$3,000 dollars. However, the issuance of 1244 stock provides the Shareholder with a maximum ordinary loss of \$50,000 (or \$100,000 in the case of the husband and wife filing a joint return.) Take advantage of this special stock issuance plan complete with resolutions for only \$50.
\$120. Independent Contract Agreement	If you would like to hire a worker as an independent contractor (and file a 1099 for them) without the worry of the IRS coming after you because of the worker's failure to complete their own tax withholdings, having an executed Independent Contractors Agreement is must. Additionally, if vicarious liability (being sued because of a worker's negligent actions) is of a concern, again an executed Independent Contractors Agreement is a necessary layer of protection. The cost for an independent contractors agreement is only \$120 at the time of incorporating.
\$60. Sub Chapter S Election	The Sub-Chapter S Corporation allows the Shareholders to avoid having their profits taxed twice because there are no corporate taxes with a Sub-Chapter S Corporation. This type of Corporation also allows the owner to avoid the majority of his/her profits from being hit with a self employment tax. Lastly, the Shareholders of an S-Corporation are able to write off their losses on their personal taxes, even against separate income (money from other employment or a spouses income on a joint return.) If you want your business to have these major tax advantages the cost is only an additional \$60. We will complete the Federal requirements and draft the Corporate articles, bylaws, resolutions and stock certificates to reflect the companies status as an S-Corporation.
\$35. Unemployment Tax Account Number (Paperwork)	If you are going to be paying a wage to yourself or other employees, state law requires you to have an Unemployment Tax ID so that you may comply with the state unemployment withholdings. You will use the Unemployment Tax ID to mail in your quarterly unemployment withholdings due to the state. We will be glade to initiate the paperwork for an additional \$35.
\$70. Unemployment Tax Account Number (Acquire)	(Please see above)For those clients who need the Unemployment Tax ID quickly, we will acquire the actual Unemployment Tax Account Number and deliver it to you for an additional \$70.
\$35. Federal Tax ID Number	The Federal Tax ID Number is required to open a business account and to put your license into the corporate name. It is also necessary for those who need to get exempt from workers compensation insurance. The tax Id is only \$35 and we will acquire the actual number for your convenience.
\$85. Workers Compensation Exemption Registration (Construction)	We will prepare the workers compensation documentation correctly and timely so there is no delay in your obtaining an exemption from costly insurance premiums. If your business is construction related your allowed up to three officer exemptions, however they must also be 10% owners. Workers Compensation Exemption Registration (Non-Construction)	We will prepare the workers compensation documentation correctly and timely so there is no delay in your obtaining an exemption from costly insurance premiums. We will prepare the documentation for exemptions and the fee will be \$85 for the first officer and \$20 per officer thereafter. <p>\$150. Security Agreement with a Loan Agreement</p>	<p>The flow of money is the grease that lubricates the wheels of commerce. Over the years important rights and protections have been developed to insure this flow continues. If you would like to loan money into your company other than that which you give in exchange for your stock, a loan agreement and promissory note is the proper way to do so. This works by having the loan agreement and promissory note signed between the corporation and Shareholder so the extra money is seen as a loan to be repaid. Additionally, a security agreement, when recorded acts as a buffer securing the loan agreement and promissory note against subsequent corporate creditors, thus keeping you first in line as the priority creditor to recover the loaned money. The fee for drafting the security agreement and helping with the state UCC filing is \$150. The loan agreement and promissory note fee is an additional \$65.</p>
<p>\$35. Sales Tax ID Number (Tax Booklet Preparation)</p>	<p>If you need to purchase products for resale you will need a Sales Tax ID Number. The Sales Tax ID allows you to purchase the products tax free prior to resale. We will prepare the tax booklet for an additional \$35.</p>
<p>\$70. Sales Tax ID Number</p>	<p>(See above information) If time is of the essence, we will acquire the actual sales tax ID number for an additional \$70.</p>
<p>\$120. Shareholders Agreement</p>	<p>When a non-publicly traded corporation is formed, we strongly advise to have an agreement among the Shareholders as to how the corporation will be organized and operate. The Agreement issued is in addition to the By-laws of the corporation and should contain clauses concerning the Buying and selling of the companies stock. It is a good idea that corporate governing procedures be established and memorialized in a written Shareholders Agreement at the time of incorporating because after the formation of the corporation matters may not be so easily agreed upon. Our Shareholders Agreement spells out the rights and obligations of the parties in the event disagreements come up. Even family corporations should consider a SHAREHOLDERS AGREEMENT, since it could settle some issues without the expense of litigation. Issues such as the rights of the shareholders to vote, rights of the directors, salaries, nominating officers and employees, buy-sell agreement concerning stock transfers of shares and endorsement rights. We will draft this agreement for only 120 at the time of incorporating.</p>
<p>\$120. Employment Agreement</p>	<p>Asset protection in case of an unforeseen bankruptcy is often overlooked when thinking of an employment agreement in Florida. A well drafted employment agreement would allow a shareholder to protect his money by paying himself a wage as an employee and utilize the unlimited cash account exemption. Set up your wage account so that no interest will be credited to it (have any interest earned on the wage account either mailed directly to you or credited to another account), deposit only the wages of the statutory head of the family into that account, and include the designation "WAGE ACCOUNT" in the account title.</p> <p>There are of course the important parameters for new hired employees such as protecting your trade secrets and other intellectual property from being stolen as well as a non-competition clause. Additionally, the beginning and ending dates of the employment period, the amount of the salary and time period it will cover, a description of duties and title for employee, agreed paid vacation days and severance pay. We will draft an agreement that entails all the above elements and more. This agreement is only \$120 at the time of incorporation.</p>
<p>\$65. Indemnification</p>	<p>When you incorporate you are protected from law suits as a Shareholder (owner of a company). However, when you act as a director or officer you have to understand there is no corporate protection if you are sued. Therefore it is strongly recommended to have us register an indemnification in your articles of incorporation and draft a contract between the corporation and the directors/officers to give them an important layer of protection against law suits. The fee for this work is only \$65 at the time of incorporating.</p>
